

- Prepare countertop by making a cutout in the counter top using the supplied cutout template
- Make sure you leave enough room in between the wall and the vessel for faucet placement
  - Put a little bit of sealant or plumbers putty on the bottom side of vessel, this is to keep the vessel from turning or moving once drain is installed
- · Line up the cutout in the countertop and the drain hole in the vessel. Place the vessel on the countertop and press firmly
- Install drain, trap and faucet according to manufactures specifications
